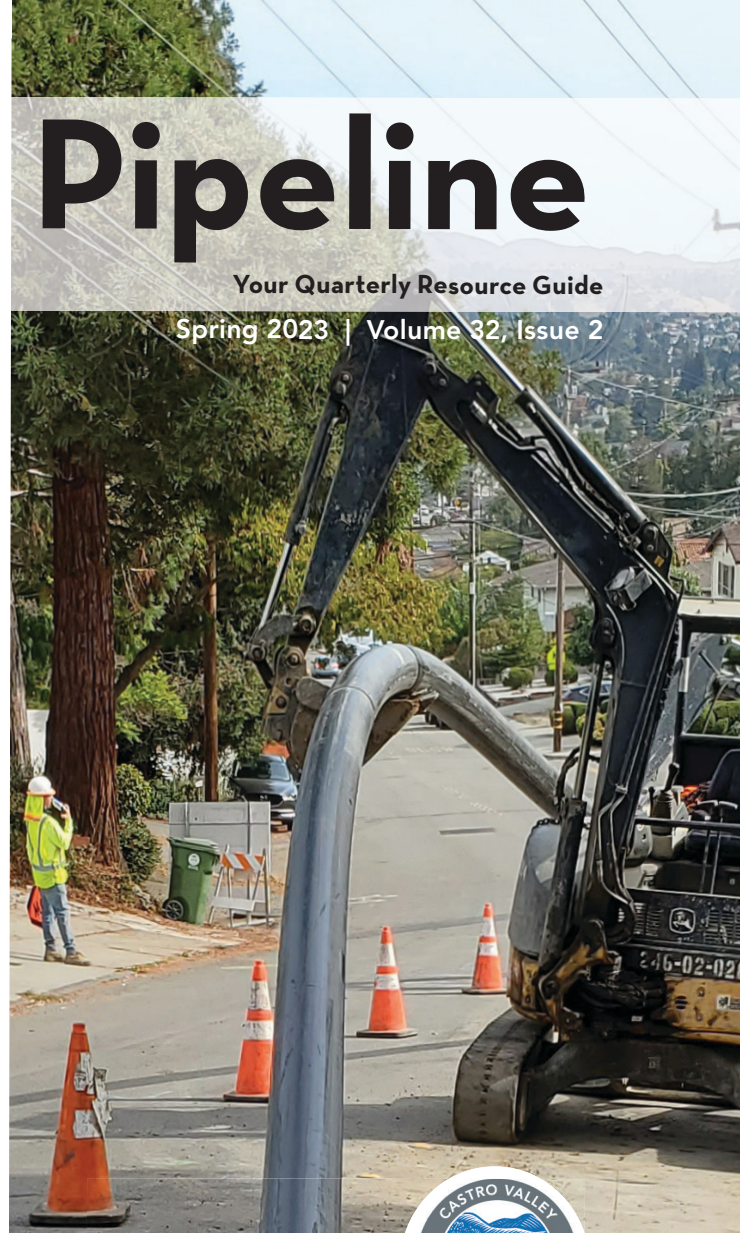

New Building Project Update

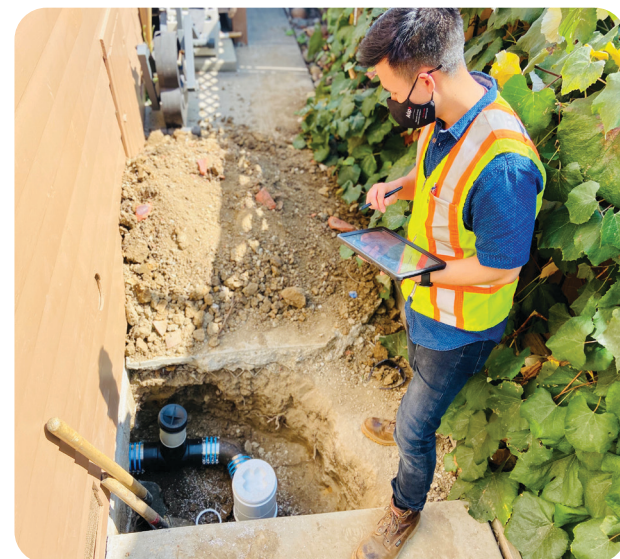


CVSan staff is excited to move forward with the Operations and Engineering (O&E) Building Project, located on the corner of East Castro Valley Boulevard and Center Street. CVSan received four bids at the bid opening meeting held on November 15, 2022. At the December 13, 2022 Special Board meeting, CVSan's Board of Directors

awarded the construction project to DL Falk Construction Inc. (DL Falk), who was the apparent low bidder at \$20,844,000. DL Falk is a local company based in Hayward and CVSan is excited to work with them on this project! Construction on the project has begun and is expected to be completed in the Summer of 2024.

Private Sewer Lateral (PSL) Program

Are you planning to sell your home in spring or summer? Have you checked the condition of your private sewer lateral? When a property is sold, the private sewer lateral is required to meet compliance with CVSan's standards. A closed-circuit television (CCTV) permit must be obtained from CVSan, and the private sewer lateral inspection performed by a sewer contractor must be witnessed by a CVSan inspector. By meeting compliance, CVSan and the new property owner can be assured that the private sewer lateral is free of any cracks, roots, and other defects. Say No to Wipes!



Single-use wipes, such as baby wipes, cleaning wipes, makeup wipes, and medicated wipes, have recently gained in popularity. Many of these products are marketed as flushable, but often do not actually break down after being flushed. Wipes can obstruct the pipes by catching on tree roots or accumulating fats, oils, and grease (FOG). Further down the public sewer main, flushed wipes can weave together and create giant rags which can get stuck in pumps, wastewater collection systems, and motors. This causes backups and equipment failures which lead to costly repairs. We can all take simple actions to ensure that Castro Valley's wastewater collection system stays functional. Special Districts Week



CVSan will commemorate Special Districts Week the week of May 15th to encourage residents of Castro Valley to be involved in their community and be civically engaged with their local government. Special districts are local government entities created by a community's residents, funded by those residents, and overseen by those residents, to provide specialized services and infrastructure. Formed in 1939 as a California Special District organized

under the Health and Safety Code of the State of California, CVSan is responsible for the operation and maintenance of the sanitary sewer collection system within the unincorporated community of Castro Valley. CVSan also oversees a refuse collection franchise for the community, manages State and local mandated recycling programs, and holds a 25% interest in the Castro Valley/Oro Loma Wastewater Treatment Facility (WWTP).

Refuel Your Fun and Save

If you are an avid outdoors person who uses one lb. propane cylinders for your camping stoves and/or lanterns, consider switching to reusable propane cylinders! These will allow you to enjoy the great outdoors while reducing the waste you produce. If you purchase a refillable 1 lb. propane cylinder, several local retailers allow you to refill it for a fraction of the cost you would pay for a new disposable propane cylinder. Sewer Repair Project

This past winter, CVSan completed work for the Gravity Sewer Repair and Rehabilitation Project, District Project 95, which repaired and rehabilitated aging sewer infrastructure at 20 project sites throughout Castro Valley. The project consisted of replacing approximately 3,500 linear feet of public sewer mains and multiple manhole rehabilitations on both public roads and within easements. In addition, several new manholes were installed to provide better access for CVSan's Collection System Maintenance staff.

Easement Access



Is there a CVSan manhole on your property? If so, there is likely an easement within your property, and CVSan staff may occasionally need access to it to perform maintenance. To protect your property and our field staff, make sure to keep the area around any manholes clear of debris or obstacles

that may prevent the maintenance of CVSan's public sewer mains.
