INTRODUCTION

Castro Valley Sanitary District (CVSan) has an ambitious plan to reduce the amount of solid waste sent to landfills and achieve Zero Waste (90 percent or more diversion from landfill) by 2029. To achieve this goal, CVSan strives to provide best practices, education, and school and community programs on recycling and reducing waste. In 2013, CVSan developed the CVSan Environmental Leader Scholarship to recognize students who are helping their school and community to reduce waste and foster sustainability by utilizing the tenets of the 4Rs: Reduce, Reuse, Recycle, and Rot, as well as other environmental protection concepts and practices. The Environmental Leader Scholarship is intended to foster environmental stewardship and the leadership of students who are taking action to encourage environmental awareness within their school and/or in the community.

INSTRUCTIONS

Who is eligible?

- Applicants must be enrolled at Castro Valley High School, Castro Valley Virtual Academy, Redwood High School, or OneSchool Global (Castro Valley location) as a high school senior with an expected graduation date of May 2024, or be a homeschooled high school senior with an expected graduation date of May 2024; or,
- Applicants must be enrolled as a high school senior (attending a school inside of CVSan boundaries) with an expected graduation date of May 2024 and must live within CVSan boundaries (provide copy of Alameda County Industries (ACI) bill from within the last six months or other proof of residency in the CVSan boundaries).
- No immediate family members of CVSan staff or Board members are eligible to apply.
- Selected applicants must plan to enroll in full-time undergraduate study at an accredited two-year or four-year college, university, or vocational-technical school for the entire 2024/2025 academic year.
- Application must be received by CVSan no later than Friday, February 9, 2024 by 2:00 p.m., no exceptions.

SCORING STANDARDS

Up to two applicants will be awarded a \$1,000 scholarship. Applicants must meet all eligibility requirements listed in the *Instructions* section above to have their application processed by CVSan. Applications received by CVSan before 2:00 p.m. on Friday, February 9th will be numbered by CVSan staff who will not participate in the scholarship scoring process. Information provided by the applicant in *Applicant Information* and *Certification Statement* will not be provided to those evaluating/scoring applicants to ensure all applications are evaluated fairly.

- In what ways has your project or leadership role increased environmental awareness within your school and/or in your community? (200 word maximum)
- Attachments You may include up to two pages (8.5"x11", double-sided) of attachments that support your project and/or scholarship application. Attachments can contain photos, illustrations, or additional information that do not fit on the application pages 5-7 above.
