

## Household Hazardous Waste

### What is Household Hazardous Waste?

Household Hazardous Waste (HHW) is a term used to identify products which no longer have a use that can catch fire or react, are toxic, corrosive, explosive, or persistent compounds. Some examples of HHW include motor oil, drain cleaner, paint (oil and latex), poisons, pesticides, fluorescent light bulbs (tubes and compact fluorescent lights), consumer electronics (televisions, computers, cell phones, and tablets), and much more.

It is illegal in California to dispose of HHW in the garbage, pour down the drain, flush down the toilet, or pour on the ground.

### Where Can I Dispose of Household Hazardous Waste?

The following facilities are open to residents of Alameda County. No appointments are needed for residents. Multi-family property owners must make an appointment and follow specific guidelines available at [www.StopWaste.org/hhw](http://www.StopWaste.org/hhw).

<p><b>CVSan Recycles Day Events</b></p> <p>Every April and August</p> <p><a href="#">(Visit our Recycles Day page for this year's date and materials accepted)</a></p> <p>Canyon Middle School</p> <p>19600 Cull Canyon Road, Castro Valley</p>	<p><b>Paint:</b> stain, shellac, solvents, thinners, additives (see below), oil paint, and latex paint.</p> <p><b>Adhesives:</b> putty, caulk, epoxy, mortar, stucco, cement, and wood glue.</p> <p><b>Auto:</b> fuel, waxes, batteries, additives, motor oil filters, and coolant/antifreeze.</p> <p><b>E-Waste:</b> computers, TVs, radios, printers, electronic devices having significant circuit boards. Visit our <a href="#">Recycles Day page</a> for a complete list.</p> <p><b>Garden:</b> sprays, fertilizers, ant traps, pesticides, herbicides, rat poison, and gopher bait.</p> <p><b>Miscellaneous:</b> pool chemicals, photo chemicals, acids &amp; caustics, household batteries, bleach &amp; cleaners, and fluorescent bulbs.</p>
<p><b>Kelly Moore</b></p> <p>3090 Castro Valley Boulevard, Castro Valley</p>	<p><b>Paint</b></p> <p>Interior and exterior architectural paint sold in containers of 5 gallons or less will be accepted (latex, acrylic, water-based, oil-based, enamel, deck coatings, primers, sealers, stains, shellacs, lacquers, varnishes, swimming pool paints, metal coatings, and rust preventatives). Both new and old paint can be dropped off, even if it is over 20 years old.</p> <p>Residents, trade painters, contractors, and businesses (that produce less than 27 gallons of hazardous waste per month) are eligible to participate.</p>
