This form must be completed in its entirety, including all written descriptions and all receipts and letters enclosed as requested. Exemptions are granted for a one-year period. You must re-apply for an exemption, annually.

In order to grant an exemption, a brief physical inspection of the exterior shall be conducted. An interior inspection may be required if the exterior inspection is insufficient. The exterior must be made available between 8:00 a.m. and 5:00 p.m., Monday through Friday, for inspection. An interior inspection (if needed) shall be arranged with the property owner. Failure to permit a random exterior inspection may result in denial of an exemption request. Garbage Exemption is granted for one year for the current owner/occupant of the property.
